

Minister's Greetings

Greetings,

Well, here we are in February. February is one of my favorite months. Many famous people were born during the month of February, Abraham Lincoln, George Washington. Ronald Reagan, Johnny Cash, Babe Ruth, and me. Rona and I celebrate our birthdays with a trip to Baskin Robins for a banana split. We also celebrate our wedding anniversary this month the same way. That means two banana splits in the same

month. Now you see why February is one of my favorite months.

February is a short month and by the end the weather is usually beginning to get milder signaling the end of winter and promising that the rebirth of Spring is just around the corner. We hope that this February will also bring with it the beginning of the end of this pandemic that has been raging for many months.

This month we observe Nirvana Day, a special service is to commemorate and honor the historical Shakyamuni Buddha who passed away on February 15, 486 BCE at Kushingara India, at the age of 80 according to our Mahayana tradition. It is believed that He entered perfect tranquility, or Nirvana, at that time.

Nirvana is the goal of Buddhist life - the blowing out of blind passions and the extinction of the ignorant self that leads to the birth of an awakened being of wisdom and compassion. In short Nirvana- IS the End of Suffering... In this lifetime and all future lifetimes.

Jodo Shinshu regards Shinjin (true entrusting) as the only and sufficient cause for birth in the Pure Land and attainment of Nirvana. Shinran explained this entrusting as the entrusting of the Other Power, the Other Power being the Power of Amida's Vow. This true entrusting in the Other Power can be understood to mean the entrusting bestowed by the Benevolence of Amida's Vow. This interpretation is the unique characteristic of Shinshu teaching.

Nembutsu, like true entrusting, is also bestowed by the Other Power or Amida's Vow. True entrusting and Nembutsu given by the Other Power keep Jodo Shinshu followers from being attached to their own merits or power and help them enjoy the life of "Egolessness" and "Naturalness" which are fundamental ideas of Buddhism.

Thus, true entrusting in The Primal Vow of Amida Buddha promises Universal Enlightenment for all beings. There is no other vow that has such sweeping power, promising hope, and life's fulfillment to all.

May the new year provide you with many opportunities to attain true entrusting in The Primal vow of Amida Buddha.


